## **Release of Liability Agreement with SJ Ranch, Inc.**

Horses are unpredictable and may react to such things as sounds, sudden movements, other horses, insects, or unfamiliar objects, persons, or animals. These are some of the risks and dangers but the signer is not relying on SJ Ranch to list all possible risks.

I fully understand and appreciate that SJ Ranch, Inc. **does not** represent or warrant the quality, character, or behavior of any horse.

As consideration for being allowed, or for my minor child being allowed, to participate at SJ Ranch, I agree to assume the full risk of any injury, including death, for myself or my child that I or my child may sustain as a result of participating. I fully release and hold harmless SJ Ranch, Inc., its directors, officers, employees and volunteers, from any and all claims from injuries, damages, or loss which may accrue to me on account of my participation, or on account of my minor child's participation in any and all activities at SJ Ranch.

I accept the responsibility for providing my own accident and medical insurance, and I accept financial responsibility for any medical expenses that my insurance does not cover.

This document cannot be modified except in writing if signed by SJ Ranch and participant. This release is meant to be valid now and in the future whenever participant enters the property.
